# FY 2023 GIWs Reminder and Update

# GIW Change Forms are due to Field offices Today, June 28, 2023.

CoC-designated Collaborative Applicants should ensure all projects eligible for renewal in the FY 2023 CoC Program Competition are correctly included on the GIW. If corrections are needed, GIW Change Forms must be completed and sent to field offices by Collaborative Applicants only.

**Please Note:** Projects awarded FY 2022 funding must apply for renewal as they were most recently awarded (or as amended). Therefore, project applicants must use Actual Rent amounts or enter the FY 2022 FMRs to calculate the rental assistance budget in their FY 2023 project applications.

- If a FY 2023 GIW requires a correction to add or revise a project that includes a rental assistance budget line item, the CoC must use the Rental Assistance Worksheet that includes a link to FY 2022 Final Fair Market Rents Documentation System to determine the FY 2022 FMR amounts that must be used during the FY 2023 application process.
- On June 21st, 2023 HUD published a revised GIW Change Form and GIW Instructions for CoCs removing incorrect references to FY 2023 FMR amounts. If you've already submitted your GIW Change Form to your local HUD field office using FY 2023 FMR amounts, HUD will work with you to make any necessary corrections. We apologize for any inconvenience this may have caused.
- During the competition, HUD will apply any FMR updates to the rental assistance BLIs (including projects with rental assistance costs based on actual rent amounts) using the FMRs that are in place at the time of the application submission deadline, as stated in 24 CFR 578.17(b)(4) of the CoC Program Interim Rule.
