# ADDENDUM NO. 3 TO RFP #COARC-0017

- **1.0** This addendum is considered to be part of the Request for Proposals (RFP) stated above. All other terms of the RFPs remain unchanged and in effect. This addendum is intended to provide additional information and/or to change requirements in the above referenced RFPs. Any information contained herein will be considered part of the RFPs and as such will be used in the evaluation of the bid responses. <u>Attention all potential bidders, if you have already downloaded or submitted your proposal prior to the bid closing date, please review this addendum and download or submit your bid response again, should this addendum modify your initial bid response.</u>
- **2.0** For Project Expansions (i.e. to expand existing CoC funded projects), proposers must:
  - 2.1 Submit a Renewal Project Proposal with "Yes Stand-Alone Renewal Application in a New Grant Expansion" selected to Question 1. Is this renewal project application requesting to consolidate or expand? under the Renewal Grant Consolidation or Renewal Grant Expansion section before Part 2 on e-snaps; and
  - 2.2 Submit a New Project Proposal with "Yes" selected to Question 3C.1. Is this a "Project Expansion" of an eligible renewal project? and select the <u>same project type</u> as the existing renewal project such as PSH, RRH, etc., not SSO-CES unless your organization is the current CES provider and would like to expand your CES project. The Riverside County CoC strongly recommends that all expansion project proposals <u>must include</u> increase in the number of persons served, beds and units.
- **3.0** Proposers are strongly encouraged to submit new proposals that meet HUD's requirements for Coordination with Housing and Healthcare as detailed under items 6.a. and 6.b. on pages 103 and 104 of the FY 2023 Continuum of Care Notice of Funding Opportunity. Please state:
  - **3.1** "New Project Application Coordination with Housing" if your proposed project meets the requirements of Coordination with Housing only; or
  - **3.2** "New Project Application Coordination with Healthcare" if your proposed project meets the requirements of Coordination with Healthcare only; or
  - **3.3** "New Project Application Coordination with Housing and Healthcare" if your proposed project meets the requirements of Coordination with both Housing and Healthcare.
