**Background:** Nominations are now open for (4) CoC Board of Governance seats for terms beginning July 1<sup>st</sup>, 2022 and ending June 30<sup>th</sup>, 2025 and (1) vacated seat for a term of July 1<sup>st</sup>, 2022 – June 30<sup>th</sup>, 2024 for the specific service areas noted below:

1. Public Sector Seat: Law Enforcement Victim Services Provider
2. Private Sector Seat: Faith Based Organization
3. Non-Profit Sector Seat: School Districts
4. Formerly Homeless Representative
5. Public Sector Seat: Governments \*Seat vacated early; Term 2022 – 2024

**Background:** The City of Riverside submitted a letter formally requesting a permanent voting position on the Board of Governance citing, “Our request is based on the large proportionality of resources and client need in the City of Riverside... The City of Riverside is also the largest service provider in western Riverside County...” The additional seat would increase the total number of governance seats to 17, with 16 of those seats being voting members. ### 4.3 2022 Homeless Point-in-Time Count Results

**Background:** The Department of Housing and Workforce Solutions (HWS), in partnership with the Riverside County Continuum of Care (CoC) and cities, coordinated the Homeless Point-In-Time Count held on the morning of February 23<sup>rd</sup>-25<sup>th</sup>, 2022. While the total count of 3,136 individuals reflects an increase of 15% from 2020 to 2022, the results reveal an 8% decrease in the number of unsheltered persons for the first time in six years. The increase is a result of an 83% increase in the sheltered population. These results point to a high-performing homeless continuum of care system, which has dramatically increased the number of shelter beds (+607) in the last two years. HWS has expanded its partnership with the Institute for Urban Initiatives who is assisting with analyzing the data and will be working with the Riverside County CoC to determine levels of investment across the county. 4.4 2021 Emergency Solutions Grant Funding Recommendations

Action Item

Background: On August 17th, 2021, the California Department of Housing and Community Development (HCD) announced the availability of approximately \$6.9 million in new federal funds for Emergency Solutions Grant (ESG) program. The County of Riverside is scheduled to receive an allocation of \$339,931, of which a minimum of 40% is required to be set aside to support rapid rehousing activities. The Board of Governance approved to prioritize \$170,368 towards rapid rehousing and \$160,000 towards street outreach during its regular meeting on April 21st, 2022.

CoC Staff released a Request for Proposals (RFP) on April 18th, 2022, soliciting local applications and hosted a non-mandatory bidders' conference on April 27th, 2022. There was a total of 6 applications (4 Street Outreach & 2 Rapid Rehousing) totaling \$1.3M. Staff has worked with the Individual Review Panel Committee and prepared the activity and funding allocations below based on the configuration of existing resources across the homelessness continuum. Services will be available to residents in all districts and based on CES service linkages.

4.5 Homeless Housing, Assistance and Prevention (HHAP)

Action Item

Background: HHAP 3 is a \$1 billion state grant that provides local jurisdictions, with flexible funding to continue efforts to end and prevent homelessness. The program is designed to build on regional coordination developed through previous rounds of Homeless Emergency Aid Program (HEAP), HHAP Rounds 1 and 2 funding, and COVID-19 funding. As a condition of funding, communities are expected to implement strategies to align the funding with other local, state, and federal funds; address racial disproportionality and achieve equitable provision of services; create a path in which persons with lived experience can help shape all levels of planning and implementation; and fund Housing First Compliant projects that are low barrier, trauma informed, and culturally responsive.

The County of Riverside's Housing and Workforce Solutions Department serves as the Administrative Entity and Continuum of Care (CoC) Lead Agency and is eligible to apply for \$4,207,199.87 by June 30th, 2022.
